Article 1 - Purpose

1.1. These general conditions ("General Conditions") regulate terms and conditions of registration and participation in the 1000 Miglia Warm Up Austria 2024.

1.2 Registration implies full acceptance of the general conditions, the Race Regulations ("RPG") to be arranged by 301 Events Gmbh and any additions and/or changes to these documents ordered by 301 Events GmbH even after the closing of entries.

1.3 The non-acceptance of these general conditions by the competitor does not allow registration to the race.

Article 2 - Admitted cars and program

2.1 301 Events GmbH independently and at its sole discretion determine the cars admitted to the Race. It is not possible to lodge a complaint or appeal against the decision of the Selection Commission.

2.2 No objection relating to the registration fees is admitted since by accepting the General Conditions, the Competitor expressly accepts the fairness of the registration fees in relation to the totality, type and quality of the services offered by 301 Events GmbH.

Article 6 - Cancellation of the event due to force majeure
